Approval of the May 2019 monthly meeting

Matters arising

Middle Street bus shelter. C’llrs Steve Davies and David Hancock informed Members that the matter had been dealt with. C’llrs Jill Gibson and David Hancock had spoken with the developer, who was aware of the gap behind the bus shelter, fully intended to comply with this, and reinstate as required. C’llr Barbara Summons felt that grass should be put back there, to maintain the rural ambience.

Tree on The Beacon. C’llr Steve Davies confirmed that he had looked at the tree in the bank close to his parents’ home. It was uncertain whether the tree was actually on The Beacon, or in the hedge. As there was some uncertainty over exactly what C’llr Jill Gibson was looking for, the matter was left for discussion in the July meeting.

Upper Beacon. C’llr Steve Davies confirmed that the contractors had been, but not done a very thorough cut. Clerk to contact P.C.C. to request a grass-cutting schedule for the season.

Lower Beacon. The Clerk had contacted One Stop to request a cut of this area. Members were unsure if the work had been done. C’llr Steve Davies to check this and inform the Clerk accordingly.
